# Job Opening Announcement

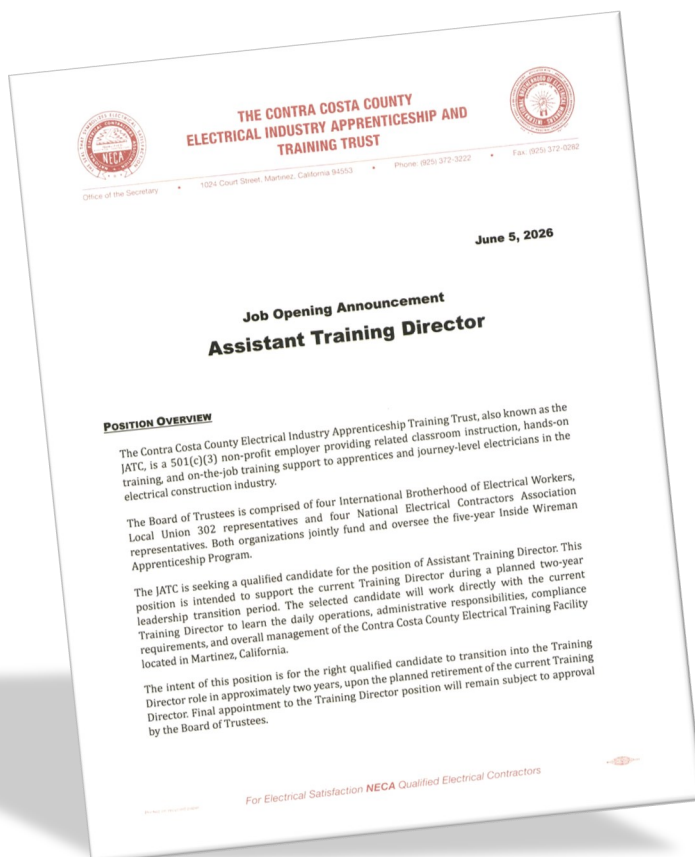
## Assistant Training Director
